Performance Evidence

Evidence required to demonstrate competence must satisfy all of the requirements of the elements and performance criteria. If not otherwise specified the candidate must demonstrate evidence of performance of the following on at least two occasions.

- using the following communication techniques:
 - listening
 - · questioning to confirm understanding and elicit information
 - reflecting and summarising
 - establishing rapport
 - negotiating
- remaining calm in difficult and uncertain situations
- making relevant referrals and responses

Knowledge Evidence

Evidence required to demonstrate competence must satisfy all of the requirements of the elements and performance criteria. If not otherwise specified the depth of knowledge demonstrated must be appropriate to the job context of the candidate.

- · organisational policies and procedures related to conducting and documenting interviews
- principles and methods of effective interviewing
- principles of managing conflict
- contingencies for unexpected behaviour and responses
- discriminative language
- barriers to effective communication

Assessment Conditions

Valid assessment of this unit requires a workplace environment or one that closely resembles normal work practice and replicates the range of conditions likely to be encountered by an individual when conducting interviews.
