Performance Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria on at least one occasion and include:

- applying antistatic procedures
- applying compatibility/environmental constraints
- applying operational safety
- calculating and maintaining net explosive quantity
- identifying colour coding, markings and labels
- identifying explosives and packaging materials
- interpreting and applying technical instructions and drawings related to packaging of explosives
- using unpackaging tools and equipment
- venting containers.

Knowledge Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria and include:

- operational knowledge of:
 - antistatic procedures
 - · appropriate explosive packaging
 - colour coding, markings
 - compatibility constraints

- effects of environmental conditions
- explosives to be unpackaged
- net explosive quantity calculations
- · operational safety
- operations and limitations of unpackaging tools and equipment
- venting procedures
- · work condition class.

Assessment Conditions

Assessors must hold credentials specified within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must satisfy the Principles of Assessment and Rules of Evidence and all regulatory requirements included within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must occur in workplace operational situations. Where this is not appropriate, assessment must occur in simulated workplace operational situations that reflect workplace conditions.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Resources for assessment must include access to:

- a range of relevant exercises, case studies and/or simulations
- acceptable means of simulation assessment
- applicable documentation, including workplace procedures, regulations, codes of practice and operation manuals
- relevant materials, tools, equipment and PPE currently used in industry.
