Application

This unit describes the skills and knowledge required to produce a knife-trimmed product using a single or multiple knife trimmer or spine trimmer while maintaining the production process, monitoring machinery for faults and problems, and rectifying minor problems according to enterprise procedures.

It applies to individuals performing a range of routine tasks, who utilise a variety of skills to ensure production of products in line with quality standards.
