#### Performance Evidence

Evidence is required to be collected that demonstrates a candidate's competency in this unit. Evidence must be relevant to the roles within this sector's work operations and satisfy all of the requirements of the performance criteria of this unit and include evidence that the candidate:

- locates and applies relevant legislation, documentation, policies and procedures
- implements the appropriate procedures and techniques for the safe, effective and efficient selection and use of polymer modified binder including:
  - interpreting project contract and specification requirements and procedures
  - interpreting project site soil and geological data
  - identifying soil and rock types
  - interpreting meteorological data
  - · interpreting material properties and test results, including compaction test results
  - interpreting project engineering
  - · ring survey information
  - interpreting project plans and drawings
  - interpreting project specifications
- works effectively with others to plan, prepare and conduct the selection and use of polymer modified binder including:
  - communicating clear and timely instructions to those involved
  - preparing for and conducting briefings, toolbox and site meetings
  - maintaining clear and legible written records and the reports

- demonstrates completion of applying the principles for the application of polymer modified binder that safely, effectively and efficiently meets all of the required outcomes on more than one (1) occasion including:
  - preparation of job plan, which includes at least five (5) of the following;
    - human resource requirements
    - plant and machinery requirements
    - construction materials requirements
    - sub-contractor support requirements
    - waste disposal requirements
    - · coordination requirements
    - activity scheduling
    - materials delivery scheduling
    - risk assessment and management requirements
    - occupational health and safety requirements
    - quality management requirements, including testing scheduling requirements
    - traffic management requirements
    - environmental requirements
    - task monitoring requirements
    - task performance monitoring requirements
    - communication requirements
    - reporting requirements
  - assessment of resource requirements including at least two (2) of the following;
    - labour
    - plant, equipment and tools
    - highway haulage vehicles
    - construction materials
    - sub-contractor services
  - ensuring set out completed to requirements including;
    - control lines
    - off-sets

## **Knowledge Evidence**

The candidate must demonstrate knowledge in applying the principles for the application of polymer modified binder through:

- accessing, interpreting and applying legislative, organisation and site requirements and procedures for:
  - risk assessment and management
  - statutory compliance
  - · workplace health and safety
  - environmental management

- quality management

- types of polymer modified binders, their specifications, applications and constraints on their use

- understanding polymer modified binder manufacturing processes
- plant and equipment capabilities and application
- operational techniques for the execution of operations
- potential operational problems in the execution of operations
- · scheduling work activities
- relationship between various areas of resources and infrastructure industries
- resource requirements
- · conducting activities scheduling
- applying estimating principles
- applying road construction sequencing
- road geometry
- pavement drainage requirements
- polymer application and related activities' terminology

#### **Assessment Conditions**

- An assessor of this unit must satisfy the requirements of the NVR/AQTF or their successors; and Industry regulations for certification and licensing; and,
- this unit must be assessed in the context of this sector's work environment; and,
- this unit must be assessed in compliance with relevant legislation/regulation and using
  policies, procedures, processes and operational manuals directly related to the industry
  sector for which it is being assessed; and,
- assessment may be conducted in conjunction with the assessment of other Units of Competency; and,
- assessment must confirm consistent performance can be applied in a range of relevant workplace circumstances; and,
- assessors must demonstrate the performance evidence, and knowledge evidence as
  outlined in this Unit of Competency, and through the minimum years of current\* work
  experience specified below in an Industry sector relevant to the outcomes of the unit; or,

- where the assessor does not meet experience requirements a co-assessment or partnership arrangement must exist between the qualified assessor and an Industry subject matter expert. The Industry subject matter expert should hold the unit being assessed (or an equivalent unit) and/or demonstrate equivalence of skills and knowledge at the unit level. An Industry technical expert must also demonstrate skills and knowledge from the minimum years of current work experience specified below in the Industry sector, including time spent in roles related to the unit being assessed; and,
- assessor and Industry subject matter expert requirements differ depending on the Australian Qualifications Framework Level (AQF) of the qualification being assessed and/or Industry Sector as follows:

Industry sector	AQF** Level	Required as sessor or Industry subject matter expert experience
Drilling, Metalliferous Mining, Coal Mining, Extractive (Quarrying) and Civil	1	1 Year
Construction	2	2 Years
Drilling, Coal Mining and Extractive (Quarrying)	3-6	3 Years
Metalliferous Mining and Civil Construction	3-6	5 Years
Other sectors	Where this Unit is being assessed outside of the Resources and Infrastructure Sectors assessor and/or Industry subject matter expert experience should be in-line with industry standards for the sector in which it is being assessed and where no Industry standard is specified should comply with any relevant regulation.	

<sup>\*</sup>Assessors can demonstrate current work experience through employment within Industry in a role relevant to the outcomes of the Unit; or, for external assessors this can be demonstrated through exposure to Industry by conducting frequent site assessments across various locations.
