### Unit Descriptor

This unit covers the conduct of thermo plastic road marking operations in the civil construction industry. It includes planning and preparing, preparing surface and set out, preparing marking materials, applying road marking materials, measuring work, and cleaning up. Licensing, legislative, regulatory and certification requirements that apply to this unit can vary between states, territories, and industry sectors. Relevant information must be sourced prior to application of the unit.

Remove pre-existing visible marks/lines where required</p> <p>2.5. Prime marked location for <b><i>lines</i></b> in readiness for road marking application</p>
3. Prepare marking materials	<p>3.1. Mix and prepare marking material in accordance with manufacturer's and job specifications</p> <p>3.2. Heat material to manufacturer's specifications to allow easy and consistent application</p> <p>3.3. Transfer marking material safely to applicator container</p>
4. Apply road marking materials	<p>4.1. Select equipment relevant to the task and prepare for operation</p> <p>4.2. Use equipment with the correct movement and pressure</p>

	<p>4.3.<i>Apply</i> road marking <i>material</i> to the surface providing an even coverage</p> <p>4.4. Identify and correct defects in the thermo plastic material</p> <p>4.5. Maintain equipment in accordance with manufacturer's specifications</p>
5. Measure work	<p>5.1. Assess, record and report work to comply with job specification</p> <p>5.2. Calculate and quantify amount of line marking completed</p> <p>5.3. Identify and report non conforming work</p>
6. Clean up	<p>6.1. Clear work area and dispose of or recycle materials in accordance with project environmental management plan</p> <p>6.2. Clean, check, maintain and store plant, tools and equipment</p>

## Required Skills and Knowledge

### Required skills

- identify and report on hazards related to the worksite and work activity
- communicate effectively to receive and clarify work instructions

### Required knowledge

Specific knowledge is required to achieve the Performance Criteria of this unit, particularly for its application in the various circumstances in which this unit may be used. This includes knowledge of the following, as required to conduct thermo plastic road marking operations:

- site and equipment safety requirements
- thermo plastic road marking activities and techniques
- road markings
- thermo plastic materials
- equipment types, characteristics, technical capabilities and limitations
- operational, maintenance and basic diagnostic procedures
- site isolation and traffic control responsibilities and authorities
- processes for the calculation of material requirements, application rates and travel speed
- materials safety data sheets and materials handling methods
- project quality requirements
- civil construction terminology
- JSAs/safe work method statements

<b>Critical aspects for assessment and evidence required to demonstrate competency in this unit</b>	<p>The evidence required to demonstrate competency in this unit must be relevant to worksite operations and satisfy all of the requirements of the performance criteria, required skills and knowledge and the range statement of this unit and include evidence of the following:</p> <ul style="list-style-type: none"> <li>• knowledge of the requirements, procedures and instructions for conducting thermo plastic road marking operations</li> <li>• implementation of requirements, procedures and techniques for the safe, effective and efficient completion of thermo plastic road marking operations</li> <li>• working with others to undertake and complete thermo plastic road marking operations that meet all of the required outcomes</li> <li>• consistent timely completion of thermo plastic road marking operations that safely, effectively and efficiently meet the required outcomes</li> </ul>
<b>Context of and specific resources for assessment</b>	<ul style="list-style-type: none"> <li>• This unit must be assessed in the context of the work environment. Where personal safety or environmental damage are limiting factors, assessment may occur in a simulated environment provided it is realistic and sufficiently rigorous to cover all aspects of workplace performance, including task skills, task management skills, contingency management skills and job role environment skills.</li> <li>• Assessment of this competency requires typical resources normally used in a resources and infrastructure sector environment. Selection and use of resources for particular worksites may differ due to the site circumstances.</li> <li>• The assessment environment should not disadvantage the participant. For example, language, literacy and numeracy demands of assessment should not be greater than those required on the job.</li> </ul>

<b>Safety requirements</b> may include:	<ul style="list-style-type: none"> <li>• OHS requirements in accordance with state or territory legislation and regulations, organisational safety policies and procedures, and project safety plan, including protective clothing and equipment, use of tools and equipment, workplace environment and safety, handling of materials, use of fire fighting equipment, use of First Aid equipment, hazard control and hazardous materials and substances</li> <li>• safe parking practices including ensuring access ways are clear, equipment/machinery is away from overhangs and refuelling sites, safe distance are kept from excavations, and areas secured from unauthorised access or movement</li> <li>• safe operating procedures including recognising and preventing hazards associated with uneven/unstable terrain, trees, pits, poles, trip hazards, dirt mounds, overhead service lines, bridges, surrounding buildings, obstructions, structures, facilities, dangerous materials, recently filled trenches, other machines, personnel, traffic control, working in proximity to others, worksite visitors and the public</li> <li>• recognising hazards and risks including uneven/unstable terrain, trees, fires, overhead and underground services, bridges, buildings, excavations, traffic, embankments, cuttings, structures and hazardous materials</li> <li>• emergency procedures related to equipment</li> </ul>
