		2.5	Amendments to daily train plans are received, validated and applied in accordance with organisational procedures
		2.6	Resources to implement planned rail traffic movements and contingency plans are identified in accordance with organisational requirements
		2.7	Documentation is amended, compiled and recorded in accordance with organisational policies and procedures
