#### **Performance Evidence**

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements, performance criteria and range of conditions on at least two separate occasions and includes:

- applying Work, Health and Safety (WHS)/Occupational Health and Safety (OHS) requirements including:
  - · emergency procedures
  - · risk control measures
  - safe working practices
- communicating with personnel and stakeholders
- identifying and responding to abnormal power generation system operating conditions using data analysis techniques and tools
- identifying critical incident and consequences
- implementing legislation, industry standards, codes of practice and regulations
- interpreting manufacturers' specifications and manuals
- recognising power generation plant or system status using diagnostic techniques
- restoring power generation system
- · reviewing response to incident
- stabilising and restoring power generation system operations
- stabilising power generation system
- using manufacturers' specifications and manuals

## **Knowledge Evidence**

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements, performance criteria and range of conditions and includes knowledge of:

- abnormal power generation system operating conditions
- generation and/or transmission capability limits
- legislation, industry standards, codes of practice and regulations
- manufacturers' specifications and manuals
- power generation plant and equipment, its location and operating parameters

- power generation system restoration operations
- power generation system stabilisation
- typical arrangements of power production plant
- WHS/OHS legislated requirements including:
  - emergency procedures
  - · risk control measures
  - safe working practices
- workplace documentation

#### **Assessment Conditions**

As a minimum, assessors must satisfy applicable regulatory requirements, which include requirements in the Standards for Registered Training Organisations current at the time of assessment.

As a minimum, assessment must satisfy applicable regulatory requirements, which include requirements in the Standards for Registered Training Organisations current at the time of assessment.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Assessment must occur in workplace operational situations. Where this is not appropriate, assessment must occur in simulated workplace operational situations that reflect workplace conditions.

Resources for assessment must include access to:

- a range of relevant exercises, case studies and/or other simulations
- relevant and appropriate materials, tools, equipment and personal protective equipment currently used in industry
- applicable documentation including workplace procedures, industry standards, equipment specifications, regulations, codes of practice and operation manuals.
