This unit of competency specifies the skills and knowledge required to safely select, check, maintain and store concreting plant, tools and equipment used for concreting work on residential, commercial, civil and industrial construction work sites.

It includes the ability to check and maintain concreting plant, hand and power tools and other concreting equipment in preparation for concreting work.

It applies to specialist concreters working as members of a team.

Licensing, legislative, regulatory or certification requirements apply to this unit of competency in some states. Relevant state and territory regulatory authorities should be consulted to confirm these requirements.
