Unit Descriptor

This unit of competency specifies the outcomes required to apply topical treatments to carpets, upholstery and soft furnishings. Topical treatments may be applied to surfaces to provide protection against the effects of odour, fire and soil.

The unit requires the ability to assess the extent of the application task through understanding client requirements and characteristics of the carpet, upholstery and soft furnishings; and to apply company policies and procedures in order to perform the task. The selection of appropriate equipment, chemicals and methods is essential for performing the task safely and efficiently.

- 3 Prepare work site
- 3.1 Hazards in the work site are confirmed and risks controlled and reassessed according to legislative, OHS and company requirements.
- 3.2 Furniture and fittings that impede cleaning operation are removed according to work order, and OHS and company requirements.
- 3.3 **Signage and barriers** are installed as required to maximise public safety during cleaning operation according to work order, and OHS and company requirements.
- 3.4 **Work restrictions** affecting completion of work order are identified and appropriate persons are promptly notified.
- 3.5 Surface area to be treated is prepared according to manufacturer specifications, work order and company requirements.
- 4 Perform treatment.
- 4.1 Treatment is performed using cleaning techniques, equipment, PPE and topical treatment chemicals according to manufacturer specifications and legislative, OHS and company requirements.
- 4.2 Treated area is compared with surrounding surface to determine need for further action according to work order and company requirements.
- 4.3 Work is performed according to work order, manufacturer specifications and legislative, OHS and company requirements.

Overview of assessment	This unit of competency could be assessed by observing demonstrations of applying topical treatment to at least two different types of carpet, upholstery and/or soft furnishing.
Critical aspects for assessment and evidence required to demonstrate competency in this unit	<p>A person who demonstrates competency in this unit must be able to provide evidence of the required skills and knowledge specified in this unit.</p> <p>In particular the person should demonstrate the ability to:</p> <ul style="list-style-type: none"> • identify type and characteristics of carpet, upholstery or soft furnishing • comply with company and legislative requirements • achieve outcomes in relation to customer work order and company requirements • apply safe and efficient topical treatment methods • select cleaning equipment and chemicals.
Context of and specific resources for assessment	<p>Assessment of essential underpinning knowledge may be conducted in an off-site context complying with relevant regulatory or Australian standards' requirements.</p> <p>Resource implications for assessment include access to:</p> <ul style="list-style-type: none"> • suitable work site or venue with carpets, upholstery or soft furnishing • equipment operating manuals and MSDS • PPE • suitable equipment and chemicals • assessment instruments, including personal planner and assessment record book • work order instructions, work plans, schedules and policy documents.
Method of assessment	<p>Assessment methods must:</p> <ul style="list-style-type: none"> • satisfy the endorsed Assessment Guidelines of the Property Services Training Package • include direct observation of tasks in real or simulated work conditions, with questioning to confirm the ability to consistently identify and correctly interpret the essential underpinning knowledge required for practical application • reinforce the integration of employability skills with workplace tasks and job roles

Guidance information for assessment	<p>Reasonable adjustments for people with disabilities must be made to assessment processes where required. 	<ul style="list-style-type: none"> • synthetic fibres, such as: <ul style="list-style-type: none"> • acrylic • nylon • polypropylene • coir matting • drapes and blinds: <ul style="list-style-type: none"> • curtains • drapery • fabric blinds • fabric pelmets • loose cushions • mats and rugs • synthetic grass • upholstery: <ul style="list-style-type: none"> • fabric • fabric wall coverings • leather • room dividers • wall hangings.

Topical treatment chemicals may include:	<ul style="list-style-type: none"> • antimicrobial agents • antistatic agents • deodorisers • fire retardants

Personal protective equipment may include:	<ul style="list-style-type: none"> • ear muffs and plugs • gloves, such as non-permeable • high-visibility vests and clothing • overalls and other protective clothing • respirators • safety glasses or goggles • safety shoes • splash-proof face masks • sun protection • tongs • ultraviolet protection • wet-work clothing.
Manufacturer specifications may include:	<ul style="list-style-type: none"> • equipment operating manuals • instructional guides • MSDS • other resources supplied by the manufacturer, such as: <ul style="list-style-type: none"> • laminated cards • notices • wall posters • product labels • safety instructions pre-printed on equipment.
Signage and barriers may include:	<ul style="list-style-type: none"> • physical barriers and restraints erected to restrict access to a site • signs complying with legislative requirements and Australian standards, warning of danger or adverse conditions, including: <ul style="list-style-type: none"> • cleaning in progress • hazardous chemicals in use or present in work area.
Work restrictions may include:	<ul style="list-style-type: none"> • amount of cleaning anticipated • client activity • employee level of literacy and communication skills • faulty or inappropriate equipment • site accessibility • site hazards • skills of the work unit or team • staffing resources • time limitations.
Waste may be either solid or liquid and include:	<ul style="list-style-type: none"> • chemicals past expiry date • litter • machine or vehicle exhaust emissions • obsolete equipment

	<ul style="list-style-type: none"> • packaging • soil • used containers • used or contaminated PPE • used or unused chemicals.
<p><i>Environmental requirements</i> may include:</p>	<ul style="list-style-type: none"> • clean-up, containment and isolation • company policies and guidelines • emergency chemical spill control measures • environmental protection agency and requirements of government departments, such as: <ul style="list-style-type: none"> • agriculture • emergency services • national parks and wildlife • hazardous materials handling • local government regulations and by-laws • low-energy cleaning methods • low environmental-impact chemicals • low-moisture cleaning methods • low water-use equipment and other water-efficient cleaning methods • non-chemical cleaning methods.
