#### **Performance Evidence**

Evidence required to demonstrate competence must satisfy all of the requirements of the elements and performance criteria. If not otherwise specified the candidate must demonstrate evidence of performance of the following on at least two occasions.

- applying the following communication techniques to workplace situations:
  - · active listening
  - · using pauses
  - using clear, concise and courteous language
  - questioning to confirm understanding and elicit information
  - selecting timing of interactions
  - selecting environments conducive to effective communication
- using communication strategies to resolve issues and problems
- completing accurate written workplace documentation
- presenting written material in the required format

### **Knowledge Evidence**

Evidence required to demonstrate competence must satisfy all of the requirements of the elements and performance criteria. If not otherwise specified the depth of knowledge demonstrated must be appropriate to the job context of the candidate.

- organisation's code of conduct, policies and procedures related to communication and interaction in the workplace
- organisation's policies and procedures related to security of information
- discriminative language
- process for referring information security breaches
- technical and professional language used in the work environment
- barriers to effective communication

#### **Assessment Conditions**

Assessors must hold credentials specified within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must satisfy the Principles of Assessment and Rules of Evidence and all regulatory requirements included within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must occur in workplace operational situations. Where this is not appropriate, assessment must occur in simulated workplace operational situations that reflect workplace conditions.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Resources for assessment must include access to:

- a range of relevant exercises, case studies and/or simulations
- acceptable means of simulation assessment
- applicable documentation, including workplace procedures, regulations, codes of practice and operation manuals
- relevant materials, tools, equipment and PPE currently used in industry.
