Performance Evidence

The candidate must demonstrate the ability to complete the tasks outlined in the elements, performance criteria and foundation skills of this unit, including evidence of the ability to:

• apply work health and safety (WHS) practices for at least one production.

In the course of the above, the candidate must:

- use required personal protective equipment (PPE) for the task
- · identify and follow safety signs and symbols
- communicate identified WHS issues to required personnel
- identify and report hazards to physical wellbeing according to workplace requirements
- assess and control risks and document risk control measures according to workplace requirements
- follow procedures for responding to incidents and emergencies.

Knowledge Evidence

The candidate must be able to demonstrate knowledge to complete the tasks outlined in the elements, performance criteria and foundation skills of this unit, including knowledge of:

- WHS rights, responsibilities and duty of care requirements as they apply to own role, duty holders and common roles within a live production environment
- jurisdictional health and safety legislative requirements that include:

- Victoria: Occupational Health and Safety Act 2004
- Western Australia: Occupational Health and Safety Act 1984.
- workplace health and safety roles in live production environments
- · mental health and well being workplace procedures
- common safety signs and symbols
- · procedures for reporting hazards, risks, incidents and accidents
- · common hazards and major causes of accidents in live production environments
- common risks to physical wellbeing of self and others in live production environments
- risk control procedures relevant to own role and common roles within a live production environment
- potential emergency situations and response procedures.

Assessment Conditions

Skills in this unit must be demonstrated in a live production environment where the conditions are typical of those in a working environment in this industry.

This includes access to:

- workplace instructions and information relating to safe work practices
- productions to which safe work practices can be applied
- interaction with others.

Assessors of this unit must satisfy the requirements for assessors in applicable vocational educational and training legislation, frameworks and/or standards. Where personal safety is a limiting factor, assessment may occur in a simulated work environment typical of those in a working environment in this industry.
