Performance Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria on at least one occasion and include:

- applying environmental constraints
- applying technical instructions and drawings related to fuzes
- calculating net explosive quantity
- conducting housekeeping
- using tools and equipment
- working safely within an explosive ordnance environment.

Knowledge Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria and include:

- operational knowledge of
 - assessment of compatibility
 - calculation of net explosive quantity
 - characteristics and limitations of fuzes
 - effects of environmental conditions
 - fuzing and defuzing procedures
 - operations, characteristics and limitations of fuzing and defuzing tools and equipment
 - organisational documentation requirements

- organisational safety information sources
- organisational safety policies and structures.

Assessment Conditions

Assessors must hold credentials specified within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must satisfy the Principles of Assessment and Rules of Evidence and all regulatory requirements included within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must occur in workplace operational situations. Where this is not appropriate, assessment must occur in simulated workplace operational situations that reflect workplace conditions.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Resources for assessment must include access to:

- a range of relevant exercises, case studies and/or simulations
- acceptable means of simulation assessment
- applicable documentation, including workplace procedures, regulations, codes of practice and operation manuals
- relevant materials, tools, equipment and PPE currently used in industry.
