- handling dangerous goods and hazardous substances
- identifying and selecting appropriate tools and equipment
- identifying types of mines
- using PPE.

## **Knowledge Evidence**

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria and include:

- basic knowledge of
  - legislative and regulatory requirements while maintaining mines
  - organisational safety requirements
- operational knowledge of
  - · colour coding, marking and labels
  - documentation requirements
  - effects of environmental conditions
  - maintenance procedures

- operational safety
- operations, characteristics and limitations of mines to be maintained
- · operations, characteristics and limitations of tools and equipment used in maintenance
- testing procedures.

#### **Assessment Conditions**

Assessors must hold credentials specified within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must satisfy the Principles of Assessment and Rules of Evidence and all regulatory requirements included within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must occur in workplace operational situations. Where this is not appropriate, assessment must occur in simulated workplace operational situations that reflect workplace conditions.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Resources for assessment must include access to:

- a range of relevant exercises, case studies and/or simulations
- acceptable means of simulation assessment
- applicable documentation, including workplace procedures, regulations, codes of practice and operation manuals
- relevant materials, tools, equipment and PPE currently used in industry.
