### **Performance Evidence**

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria on at least one occasion and include:

- displaying mechanical advantage
- · testing and preparing explosives, accessories and equipment
- using tools
- ensuring there is no injury to personnel, no damage to equipment, no breach of safety procedures and a charge initiates
- reporting/discarding faulty components
- segregating explosives types as required
- applying manual handling and team lifting techniques
- using PPE
- handling dangerous good and hazardous substances safely.

## **Knowledge Evidence**

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria and include:

Operational knowledge of:

- composition of teams and roles and responsibilities of team members
- · composition, safety distances and restrictions related to approved explosives
- · explosives handling and transportation procedures
- identification and purpose of markings for explosive ordnance and explosive ordnance

packaging

- mathematical calculations related to demolition operations
- safety precautions related to demolition operations
- United Nations classification and segregation requirements of explosive ordnance
- construction, characteristics and limitations of military targets.

#### **Assessment Conditions**

Assessors must hold credentials specified within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must satisfy the Principles of Assessment and Rules of Evidence and all regulatory requirements included within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must occur in workplace operational situations. Where this is not appropriate, assessment must occur in simulated workplace operational situations that reflect workplace conditions.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Resources for assessment must include access to:

- a range of relevant exercises, case studies and/or simulations
- acceptable means of simulation assessment
- applicable documentation, including workplace procedures, regulations, codes of practice and operation manuals
- relevant materials, tools, equipment and PPE currently used in industry.
