#### **Performance Evidence**

A person demonstrating competency in this unit must satisfy all of the elements, performance criteria and foundation skills of this unit. If a specific volume or frequency is not stated below, then evidence must be provided that the following requirements have been performed on at least one occasion:

- set up finishing and coating operations according to workplace requirements and site procedures
- conduct finishing and coating operations according to safe work procedures
- prepare coating chemicals in line with manufacturer recommendations and site procedures
- assess and rectify defects and faults during the coating process in line with safe work procedures
- package finished products according to organisational guidelines
- record and report faults and finishing and packing process information
- perform emergency stop.

# **Knowledge Evidence**

A person competent in this unit must be able to demonstrate knowledge of:

- safe work procedures involved in finishing and packing finished products
- emergency response procedures relevant to the job (accident, fire, serious process fault)
- environmental protection requirements relating to the safe disposal of waste material (including preservative treated timber), the safe use and storage of chemicals, and the cleaning of plant, tools and equipment
- criteria for recycling and re-using material with defects
- hazards and risks associated with finishing and coating fabricated products, including environmental hazards and risks
- problem identification and resolution strategies, common fault finding techniques, and typical product and coat defects
- procedures for the operation and maintenance of tools and equipment
- procedures for recording and reporting equipment and product faults, and process information.

## **Assessment Conditions**

The following resources must be made available:

- work order
- product to coat
- coating equipment and tools
- coating chemicals
- material for packaging
- personal protective equipment required for finishing products.

Competency is to be assessed in the workplace or a simulated environment that accurately reflects performance in a real workplace setting.

#### Assessors must:

- hold the appropriate assessor competency standards as outlined in regulations; and
- be able to demonstrate vocational competencies at least to the level being assessed; and
- be able to demonstrate how they are continuing to develop their VET knowledge and skills as well as maintaining their industry currency and assessor competence.
