	1.3 Obtain type and quantity of veneer to be cut from veneer production process.
	1.4 Select cutting process and plan in line with work order.

2. Operate equipment to cut veneer	2.1 Use equipment in line with organisational safety procedures, manufacturer's instructions and environmental protection practices.
	2.2 Complete pre start up equipment checks to ensure operational effectiveness.
	2.3 Coordinate conveyor and guillotine operation with veneer production.
	2.4 Select optimal cutting positions to minimise defects and maximise full width sheets.
	2.5 Complete cutting and monitor conveyor feed rate regularly for material flow problems.
	2.6 Cut veneer to specification and assess veneer visually throughout cutting process for strength, gaps and defects.
3. Redistribute material	3.1 Direct material to storage or processing operations in line with organisational procedures.
	3.2 Dispose of incorrect cuts, off cuts and defective material in line with environmental protection practices.
	3.3 Clean work area in line with organisational safety procedures.
	3.4 Record and report production outcomes and equipment faults to appropriate personnel.
