This unit applies to enrolled nurses, registered with the Nursing and Midwifery Board of Australia (NMBA), seeking specialisation in enrolled nurse work that is carried out in consultation and collaboration with registered nurses, and under direct or indirect supervisory arrangements aligned to the NMBA regulatory authority legislative requirements.

The skills in this unit must be applied in accordance with Commonwealth and State/Territory legislation, Australian Standards and industry codes of practice.

No occupational licensing, certification or specific legislative requirements apply to this unit at the time of publication.

5. Address contemporary issues in sexual and reproductive health.
 - 5.1. Apply requirements of influences that shape sexuality in current and historical contexts.
 - 5.2. Identify, educate and evaluate contraception choices to support and provide health education about available options.
 - 5.3. Educate and support pregnancy choices and options for unplanned pregnancies.
 - 5.4. Provide information and referral options on risk-taking behaviours and educate to promote safe sex practices.
