Knowledge Evidence

Demonstrate knowledge required to complete tasks outlined in elements and performance criteria of this unit:

- anatomy and physiology of the renal system and clinical manifestations and associated pathophysiology of the stages of renal impairment
- underlying environmental and social factors contributing to renal impairment in the general population in Australia and the higher rates experienced within Aboriginal and Torres Strait Islander communities
- renal impairment conditions and risk factors:
 - diabetic nephropathy
 - glomerulonephritis
 - hypertensive nephropathy

- polycystic kidney disease
- reflux nephropathy
- · kidney stones
- kidney transplant
- clinical manifestations:
 - hypertension
 - anaemia
 - bone disease
 - cardiovascular disease
 - impaired immunity

- complications and impact of renal impairment:
 - uraemic breath
 - unusual and metallic taste
 - anorexia
 - nausea and vomiting
 - lethargy
 - change in urination
 - confusion
 - pain
 - increase in depression
 - stages of grief and loss
 - sexual dysfunction
 - general malaise
 - cardiovascular events
 - infections
 - uraemic frost
 - pruritus
 - restless leg syndrome
- screening and prevention
- immunity and the importance of vaccinations
- changing educational needs
- assessment of renal function and diagnostic procedures:
 - common pathology tests to diagnose and evaluate
 - interventional and investigational procedures used in the diagnosis and management
- management:
 - factors that can slow the progression and changes across the continuum of renal disease

 - disability support
 - · family support
 - transport to appointments
 - accommodation
- organisations associated with palliative care and advance care planning.
- self-management strategies:
 - healthy lifestyle
 - exercise
 - renal diet
 - fluid requirements
 - medication regime
 - care of dialysis access
 - recognising progressive symptoms
 - vaccination regime
 - diabetes care
 - · cardiovascular disease care
 - dental care
 - optometry and ophthalmic care
 - skin care.

Assessment Conditions

To be eligible to apply for registration as an enrolled nurse and to practice in Australia, each applicant must complete a Diploma of Nursing program accredited by the Australian Nursing and Midwifery Accreditation Council (ANMAC) and approved as 'an approved program of study' by the Nursing and Midwifery Board of Australia (NMBA) in accordance with the Enrolled Nurse Accreditation Standards.
