- Strengths and weakness of the Australian health care system, with emphasis on the local area

the context of the identified work role

This includes the ability to:

- Apply professional standards of practice:
  - ANMC code of conduct
  - ANMC code of ethics
  - ANMC national Enrolled/Division 2 nurse competency standards
  - state/territory Nurse Regulatory Nurses Act
  - state/territory Nursing and Midwifery Regulatory Authority standards of practice
  - scope of nursing practice decision making framework
- Use oral communication skills (language competence) required to fulfil job roles as specified by the organisation, including:
  - interviewing techniques
  - asking questions
  - active listening
  - asking for clarification
- Use interpersonal skills, including working with others, using sensitivity when dealing
  with people and relating to persons from differing cultural, social and religious
  backgrounds
- Use written communication skills (literacy competence) required to fulfil job roles as specified by organisation/service, including skills that may range from reading and understanding client documentation to completion of written reports

## Context of and specific resources for assessment:

- This unit is most appropriately assessed in the clinical workplace or in a simulated clinical work environment and under the normal range of clinical environment conditions
- Where, for reasons of safety, access to equipment and resources and space, assessment takes place away from the workplace, simulations should be used to represent workplace conditions as closely as possible

#### Method of assessment

- Observation in the workplace
- Written assignments/projects
- Case study and scenario as a basis for discussion of issues and strategies to contribute to best practice
- Questioning verbal or written
- Role play/simulation

#### Access and equity considerations: •

- All workers in the health industry should be aware of access and equity issues in relation to their own area of work
- All workers should develop their ability to work in a culturally diverse environment
- In recognition of particular health issues facing Aboriginal and Torres Strait Islander communities, workers should be aware of cultural, historical and current issues impacting on health of Aboriginal and Torres Strait Islander people
- Assessors and trainers must take into account relevant access and equity issues, in particular relating to factors impacting on health of Aboriginal and/or Torres Strait Islander clients and communities
