Evidence of the ability to:

 - footwear

Safety data sheets

- describe where safety data sheets are kept and the information they contain
- explain where information about safe levels for discharges or emissions can be found

Information sources

• describe the location of machine manuals, safety and other documentation relevant to this task and outline the information included in them.

Assessment Conditions

Gather evidence to demonstrate consistent performance in conditions that are safe and replicate the workplace. Noise levels, production flow, interruptions and time variances must be typical of those experienced in the Support field of work and include access to special purpose tools, equipment and materials.

Assessors must satisfy NVR/AQTF assessor requirements.
