# Assessment Requirements for MARI001 Comply with regulations to ensure safe operation of a vessel up to 12 metres

## Performance Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria on at least one occasion and include:

- applying regulations pertaining to the safe operation of a vessel
- applying safety management plan standards and emergency operating procedures
- conducting inductions for crew where applicable
- demonstrating an understanding of the duties and responsibilities relating to a Coxswain
- obtaining and complying with information from commonwealth, state and territory Acts, legislation, codes of practices and other publications relating to the safe navigation of a vessel
- providing appropriate level of detail in recordkeeping.

## Knowledge Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria and include knowledge of:

- assisting in distress
- certificates on board a vessel
- contents of marine notices, annual notices to mariners
- distress signals
- duties and responsibilities of the person in charge
- International Association of Lighthouse Authorities (IALA) Buoyage System A
- International Regulations for Preventing Collisions at Sea
- large commercial traffic
- lifesaving and firefighting appliances
- lights, shapes and sounds
- logbook or vessel record book
- marine pollution prevention
- National Standard for Commercial Vessels (NSCV) Part C Section 7
- operational areas and classifications of vessels
- state and territory marine legislation
- work health and safety (WHS)/occupational health and safety (OHS) legislation.

## **Assessment Conditions**

Assessors must satisfy National Vocational Education and Training Regulator (NVR)/Australian Quality Training Framework (AQTF) assessor requirements.

Assessment must occur in workplace operational situations where it is appropriate to do so; where this is not appropriate, assessment must occur in simulated workplace operational situations that reflect workplace conditions.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Resources for assessment must include access to:

- tools, equipment, machinery, materials and personal protective equipment currently used in industry
- applicable documentation such as legislation, regulations, codes of practice, workplace procedures and operational manuals
- range of relevant exercises, case studies and/or simulations.
