# Assessment Requirements for MEM20017 Produce keys by duplication

### **Modification History**

#### **Performance Evidence**

Evidence required to demonstrate competence in this unit must be relevant to and satisfy the requirements of the elements and performance criteria and include:

- following work instructions, standard operating procedures (SOPs) and safe work practices
- interpreting conversion charts, software, reference books and samples to identify blank requirements for keys used across different industries
- selecting appropriate duplicating method for key type and system
- measuring key dimensions and identifying key type appropriate to the task on at least two
  occasions
- setting up and safely using cutting and duplicating equipment to produce keys on at least two occasions
- testing and adjusting key operation, checking calibration and finishing keys
- testing, calibrating and adjusting cutting machine.

Note: Where a volume and/or frequency is not specified, demonstration must be provided at least once.

## Knowledge Evidence

Evidence required to demonstrate the required knowledge for this unit must be relevant to and satisfy the requirements of the elements and performance criteria and include knowledge of:

- safe work practices and procedures and use of personal protective equipment (PPE)
- key types
- requirements for key productions
- different techniques for cutting and duplicating
- tools and equipment for machine cutting
- key systems and blanks
- spacings, depths, angles, shapes and other measurements relevant to cutting keys
- terminology for key production
- tools, equipment and accessories for duplicating keys
- identification marking procedures
- key storage and packaging procedures
- techniques for testing, calibrating and adjusting cutting machine.

#### **Assessment Conditions**

- Assessors must:
  - have vocational competency in duplicating keys at least to the level being assessed with relevant industry knowledge and experience
  - satisfy the assessor requirements in the *Standards for Registered Training Organisations 2015 or its replacement* and comply with the *National Vocational Education and Training Regulator Act 2011*, its replacement or equivalent legislation covering VET regulation in a non-referring state/territory as the case requires.
- Where possible, assessment must occur in operational workplace situations. Where this is
  not possible or where personal safety or environmental damage are limiting
  factors, assessment must occur in a sufficiently rigorous simulated environment that
  reflects realistic operational workplace conditions that cover all aspects of workplace
  performance, including environment, task skills, task management skills, contingency
  management skills and job role environment skills.
- Conditions for assessment must include access to all tools, equipment, materials and documentation required including relevant workplace procedures, product and manufacturing specifications.
- Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.
