#### MSMRV376 Install recreational vehicle windows and doors

## **Modification History**

Release 1. Supersedes and is equivalent to MSMRV320 Fit windows and doors to a recreational vehicle. Changes to application, elements, performance criteria and assessment requirements. Range of conditions removed.

## **Application**

This unit describes the skills and knowledge required to install windows (such as front, rear, kitchen, bedroom and bathroom windows) and doors (such as entrance, access, trunk and tunnel boot doors) in recreational vehicles.

The unit applies to a person working in a recreational vehicle manufacturing facility who undertakes routine tasks according to job instructions, plans/specifications and procedures and uses discretion and judgement in selecting equipment, services and contingency measures. They work with a high degree of self-direction and limited supervision. They apply known solutions to routine problems and report non-routine problems according to procedures. They are responsible for their output and have limited responsibility for the output of others.

No licensing or certification requirements exist at the time of publication. Relevant legislation, industry standards and codes of practice within Australia must be applied.

1. Prepare to install windows and doors	1.1 Identify window/door installation requirements from job and manufacturer's instructions
	1.2 Select and check all required tools and equipment are ready to use
	1.3 Gather windows, doors and other items required by job specifications, and check they meet quality requirements and are ready for installation
	1.4 Identify hazards and hazard controls and check the hazard controls are in place and operating
	1.5 Check the recreational vehicle and work area are ready for installing the windows/doors

2. Install windows and doors	2.1 Measure, cut and fit seals and mouldings according to job instructions
	2.2 Correctly position the frame and fasten it according to manufacturer's instructions
	2.3 Fit and complete installing the window/door to the frame according to the manufacturer's instructions
	2.4 Check the window/door is installed correctly according to job instructions and quality requirements and rectify any deficiencies
3. Complete the installation according to workplace procedures	3.1 Clean up the recreational vehicle in readiness for the next task
	3.2 Clean up the work area, identify items for recycling and dispose of waste
	3.3 Identify, tag and report any damage to equipment and tools
	3.4 Check, clean and do routine maintenance on equipment and tools and store them and unused materials
	3.5 Complete task outcome documentation
