#### Application

This unit describes the skills and knowledge required to follow basic processes for the production of a textile item. The item may be a fabric or other textile product. It includes the use of a limited range of tools, equipment and techniques. Equipment may be commercial or craft level. Production processes may include one or more of spinning, weaving, felting, knitting or sewing. Materials are those which do not require complex processing or handling.

This unit applies to individuals preparing for work in the textile, clothing and footwear industry, usually within a pre-employment training program. Work is carried out under supervision.

No licensing or certification requirements exist at the time of publication. Relevant legislation, industry standards and codes of practice within Australia must be applied.
