# Assessment Requirements for MSTAT4021 Produce woven textile samples

#### **Performance Evidence**

There must be evidence the candidate has completed the tasks outlined in the elements and performance criteria of this unit, and demonstrated the ability to:

• produce at least two different woven samples according to design specifications.

#### **Knowledge Evidence**

There must be evidence the candidate has knowledge of:

- · safe work practices and procedures and use of personal protective equipment
- types and styles of woven fabrics
- production requirements, including:
  - tension
  - colour
  - pattern
- weaving modification techniques
- weaving loom techniques, including:
  - block weaves
  - hatchings
  - inlay
  - leno
  - plain weave
  - rya
  - satin or sateen weave
  - soumak
  - Spanish lace
  - twill weave
  - warp faced weaves
  - weft faced weaves
  - wrapped ends

- yarn types and characteristics, including:
  - singles yarns
  - plied yarns
  - cotton
  - hand spun
  - metallics
  - novelty
  - nylon filament
  - rag strips
  - ribbon
  - rovings
  - silk
  - silk tops
  - synthetics
  - unspun fleece
  - wool
  - fault-finding procedures, typical fault conditions and how to rectify, including:
    - broken warp threads
    - foreign matter
    - holes
    - incorrect beating of weft
    - incorrect threading, tie-up, treadling of design
    - incorrect use of equipment
    - incorrect use of materials
    - incorrect warp tension
    - loom or equipment faults
- simple weaving equipment maintenance techniques
- quality practices
- recording and reporting practices for weaving operations.

#### **Assessment Conditions**

Skills must have been demonstrated in the workplace or in a simulated environment that reflects workplace conditions and contingencies. The following conditions must be met for this unit:

- use of suitable facilities, equipment and resources, including:
  - design specifications
  - weaving materials, tools and equipment
  - workplace procedures.

Assessors must satisfy the NVR/AQTF mandatory competency requirements for assessors.
