## Performance Evidence

There must be evidence the candidate has completed the tasks outlined in the elements and performance criteria of this unit, and demonstrated the ability to:

- prepare for, conduct and document the outcomes of at least two different site inspections to determine client and site requirements for manufactured textile products.

## Knowledge Evidence

There must be evidence the candidate has knowledge of:

- workplace and site procedures for work health and safety
- hazard identification and control measures, including those associated with working at heights
- range of products and services offered by the workplace
- client service and communication standards and practices:
  - active listening and questioning techniques
  - clear verbal explanation of product features
- factors and variables that impact manufacture and installation:
  - types of materials:
    - applications
    - limitations
    - service life
  - types of products and equipment, including strengthening and fastening devices
  - operating principles and mechanisms
  - costs
  - timelines
  - colours
  - size, dimensions and shape
  - delivery and installation dates

- installation procedure to be followed
- documentation requirements for recording outcomes of site inspections and key inclusions
- features and use of different measuring instruments
- critical dimensions that may impact manufacture and installation and calculations required for measuring those dimensions:
  - area
  - perimeter
  - volume
  - mass
  - scales and ratios (ingredients/elements and triangulation)
  - addition
  - subtraction
  - multiplication and division processes.

## Assessment Conditions

Skills must have been demonstrated in the workplace or in a simulated environment that reflects workplace conditions and contingencies. The following conditions must be met for this unit:

- use of suitable facilities, equipment and resources, including:
  - installation sites
  - measuring devices and other inspection equipment
  - product information
  - workplace procedures.

Assessors must satisfy the NVR/AQTF mandatory competency requirements for assessors.
