It includes maintaining dam safety mechanisms, interpreting technical documentation, investigating and resolving maintenance problems, collecting and analysing technical information.

This unit applies to those working as field and operational staff with a specific responsibility for the maintenance of dams. Those undertaking this unit would work under appropriate supervision while performing routine tasks in a limited range of familiar contexts.
