Those undertaking this unit would work autonomously, lead personnel and review and analyse information and data about aquifers whilst performing sophisticated tasks in a range of contexts.

- **3.3** Recommend changes to plan objectives and implementation procedures
- **3.4** Provide advice and guidance to groundwater stakeholders
