Release 1. This is the first release of this unit of competency in the NWP National Water Training Package.

Application

This unit involves the skills and knowledge required to maintain and repair irrigation channels and drains.

It includes preparing worksite, maintaining irrigation channels, drains and associated fittings, checking work, restoring worksite and finalising work.

This unit applies to those working as field and operational staff with responsibility for carrying out planned and reactive maintenance and repair work on rural water delivery systems. Those undertaking this unit would work under appropriate supervision using familiar resources as required. They will perform routine tasks, ensuring minimum damage to the environment, in a range of familiar contexts.

No licensing, legislative or certification requirements apply to this unit at the time of publication.
