### Application

This unit describes the skills required to disinfect network assets including where additional disinfection of the supply is required. This includes planning and preparing the work site and performing volumetric calculations.

This unit applies to those working as field and operational staff with responsibility for the operation and maintenance of chemical dosing equipment.

The skills and knowledge described in this unit must be applied within the legislative, regulatory and policy environment in which they are carried out. Organisational policies and procedures must be consulted and adhered to.

Those undertaking this unit would work independently under indirect supervision while performing routine tasks with a moderate level of complexity in a familiar context.

No licensing, legislative or certification requirements apply to unit at the time of publication.
