#### **Performance Evidence**

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements and performance criteria on at least one occasion and includes:

- collecting data and completing required documentation
- completing reports
- conducting routine plant inspections
- · identifying and reporting faults
- identifying control system faults
- making process adjustments including at least one of the following:
  - backwash settings
  - filter aid dosing
  - filtration rate
  - pH correction
- monitoring test results and processes
- performing process calculations
- solving operational problems
- taking samples and conducting tests
- using safety and personal protective equipment

## **Knowledge Evidence**

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all the requirements of the elements and performance criteria and includes knowledge of:

- filtration equipment operation, capacity and limitations
- interpretation and use of safety data sheets
- pressure sand filters, gravity sand filters and backwashing
- principles of granular media filtration processes
- relevant legislation, regulations and workplace procedures

- · risk factors and potential hazards relating to granular media filtration processes
- · system layout

#### **Assessment Conditions**

Assessors must hold credentials specified within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must satisfy the Principles of Assessment and Rules of Evidence and all regulatory requirements included within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must occur in workplace operational situations where it is appropriate to do so; where this is not appropriate, assessment must occur in simulated workplace operational situations that replicate workplace conditions.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Resources for assessment must include access to:

- relevant and appropriate materials, tools, equipment and personal protective equipment currently used in industry
- applicable documentation including legislation, regulations, codes of practice, workplace procedures and operation manuals.
