Application

This unit describes the performance outcomes, skills and knowledge required to protect assets and minimise security risks, by implementing asset restrictions and advising third parties of security requirements.

This unit applies to those working in a role where security of human and physical assets is a requirement. Those undertaking this unit work independently and as part of a team, using support resources and performing routine tasks in a range of familiar and unfamiliar contexts.

- 1.2. Investigate suspicious activity and seek expert advice in accordance with organisational requirements.
- 2.1. Restrict access to authorised personnel and identify potential threats.
- 2.2. Identify breaches, take action to deal with the breach and report to appropriate personnel.
