PUAFIR014 Supervise preparation and loading of product into aircraft

Modification History

Release 1.0 This is the first release of this unit of competency in the PUA Public Safety Training Package.

Application

This unit of competency involves the skills and knowledge required to supervise the preparation and loading of product into aircraft for dispersal as part of an incident response strategy. It includes ensuring safety of support personnel, supervising storage and handling of product, reviewing environmental considerations, supervising preparation and loading of product, supervising storage of prepared product, overseeing transfer of product into an aircraft and supervising the response to a spillage.

The unit is applicable to personnel at an airbase who are responsible for preparing products such as fire retardant or fire suppressant such as foam, gel, water (without additives) or an oil spill dispersant and loading it into fixed wing or rotary wing aircraft. Work is performed independently or under limited supervision as a single operator or within a team environment. Authorisation to perform this role is subject to organisational policies and procedures.

The fire sector is those sections of government departments, statutory authorities or agencies that have responsibility under jurisdictional arrangements for the delivery of firefighting and fire management services.

No licensing, legislative or certification requirements apply to this unit at the time of publication.

Pre-requisite Unit

It is essential that the prerequisite units listed below are obtained prior to the issuance of this unit to individuals with the fire sector or the units contributing to the attainment of a fire qualification.

1 Ensure safety of support personnel	<p>1.1 Initial briefing is obtained from air base manager and communication is maintained throughout operation</p> <p>1.2 Support personnel involved in the preparation and loading of product are briefed, tasked and their performance is monitored</p> <p>1.3 Site and job hazards are identified, risks are assessed and control measures are implemented</p> <p>1.4 Trained personnel who are unfamiliar with product and equipment are identified and provided with information, instruction and supervision on safe techniques</p> <p>1.5 Liaison is maintained with pilots and task supervisors on product quality and loading requirements of aircraft</p>
2 Supervise storage and handling of product	<p>2.1 Emergency and first aid procedures on Safety Data Sheets for product being handled are identified and followed</p> <p>2.2 Storage requirements for product are identified and established</p> <p>2.3 Handling procedures for product are implemented and complied with</p>
3 Review environmental considerations	<p>3.1 Site is confirmed after consideration of environmental factors and organisational requirements</p> <p>3.2 Preventative actions are identified for protecting water supplies and are implemented, as required</p>
4 Supervise preparation and loading of product	<p>4.1 Equipment for preparing product is set up and operated in accordance with manufacturers' instructions</p>

- 4.2** Equipment issues are resolved through systematic checking of operation
 - 4.3** Quality of prepared product is tested using approved equipment and adjustments are made, as required
- 5 Supervise storage of prepared product**
 - 5.1** Product is stored in accordance with manufacturers' instructions and organisational requirements
 - 5.2** Quality of stored product is monitored in accordance with manufacturers' requirements, as required
 - 5.3** Storage tank is flushed and waste material is collected for disposal when a contaminant is detected
- 6 Oversee transfer of product into aircraft**
 - 6.1** Attaching transfer equipment and transferring product to the aircraft is conducted under pilot supervision
 - 6.2** Equipment is cleaned at the conclusion of the transfer operation, as required
- 7 Supervise response to spillage**
 - 7.1** Organisational procedures are implemented for product spillage
 - 7.2** Emergency and first aid procedures on Safety Data Sheet for product are followed
 - 7.3** Personnel affected by spillage of fire control chemicals are washed using eye, hand and shower facilities, as appropriate, and a report is filed

Foundation Skills

Foundation skills essential to performance are explicit in the performance criteria of this unit of competency.

Range of Conditions

Range is restricted to essential operating conditions and any other variables essential to the work environment.
