- 1.4 Possible threats are observed and monitored so an appropriate plan of action can be prepared
- 2.1 Target position is established via aural and visual observation, and bearing and distance are estimated
- 2.2 Type of weapon (if present) is identified and classified through visual or aural recognition, or by crater analysis
- 2.3 Enemy capability is estimated
- 2.4 Hostile action is monitored from prepared position
- 2.5 Communications with stakeholders is maintained so that relevant information can be provided
- 3.1 Target is described to stakeholders
- 3.2 *Records* are maintained in accordance with *standard procedures*
