Unit Descriptor

This unit covers the competency required to control snipers on operations and in training.

While this work will be undertaken under the command of a higher authority it also requires the individual to provide *technical advice* and to be responsible for the implementation of the commander's intent.

Supervising sniper operations includes the responsibility for effectively using available resources and for planning the employment of, organising, directing, coordinating and controlling, snipers for the accomplishment of assigned missions. It also includes responsibility for the health, welfare, morale and discipline of assigned personnel.

- 2.1 *Information and intelligence* in support of operations is assembled and analysed
- 2.2 *Risk* is identified and managed in accordance with standard procedures
- 2.3 *Decision making process* is conducted in accordance with standard procedures
- 2.4 Sniper teams to perform specialist operations are identified and advised
- 2.5 Plans are adjusted to accord with resource availability, in accordance with operational and organisational policy
- 2.6 Orders are prepared and issued to participating sniper teams indicating their missions, tasks, resources, constraints and limitations in accordance with standard procedures
- 2.7 *Battle procedure* is supervised and conducted in accordance with standard procedures
- 2.8 *Liaison* is conducted in accordance with operational requirements and standard procedures
- 3.1 Operations are monitored to ensure efficiency of their conduct and achievement of the mission
- 3.2 Appropriate battlespace operating systems are

- 4.4 *Reports and returns* are compiled and processed in accordance with standard procedures

Critical aspects for assessment and evidence required to demonstrate competency in this unit Assessment must confirm the ability to plan sniping operations to develop and deliver orders and instructions; to identify the application of legislative requirements; to coordinate multiple activities; and to provide debriefing, reports and appropriate documentation associated with the operations.
