# **Application**

This unit describes the skills and knowledge required to monitor and control the effects of blasting on the environment in civil construction, coal and metalliferous mining and extractive sectors. It includes evaluating environmental hazards and controls, implementing environment monitoring systems, and reviewing and auditing strategies.

It applies to those working in technical specialist roles. They generally contribute to the development of technical solutions to complex and non-routine problems.

Licensing, legislative and certification requirements that apply to this unit can vary between states, territories, and industry sectors. Users must check requirements with relevant body before applying the unit.
