## **Application**

This unit describes the skills and knowledge required to install sewer pipelines in civil construction, including determining sewer pipeline requirements, installing bedding and installing and testing sewer pipeline.

It applies to those working in operational roles. They generally work under minimal supervision to undertake a broad range of tasks in varied work contexts, using some discretion and judgement in selecting equipment, services or contingency measures.

Licensing, legislative and certification requirements that apply to this unit can vary between states, territories, and industry sectors. Users must check requirements with relevant body before applying the unit.

	3.5 Position side support and overlay beside the pipes as required
	3.6 Check sewer pipeline system support structure
	3.7 Monitor backfill procedure and confirm work is completed to specification
	3.8 Construct manholes, inspection and valve chambers, minor structures and thrust blocks according to job requirements
4. Test sewer pipeline	4.1 Perform sewer system test procedures establishing functionality and serviceability
	4.2 Complete records and report test results according to job requirements
5. Conduct clean-up activities	5.1 Clear work area and dispose of or recycle materials according to site requirements
	5.2 Clean, check, perform maintenance on and store plant, tools and equipment according to manufacturer specifications and site requirements
