The candidate must demonstrate knowledge in preparing a civil works cost estimate through:

- accessing, interpreting and applying legislative, organization and site requirement and procedures for:
 - risk assessment and management
 - statutory compliance
 - work health and safety
 - · environmental management
 - cultural and heritage
 - quality management
 - communication
- calculating areas, volumes, labour hours, materials quantities, sub-contractor service capabilities, productivity and required hours
- maintaining cost records
- providing clarification and advice

Assessment Conditions

- An assessor of this unit must satisfy the requirements of the NVR/AQTF or their successors; and Industry regulations for certification and licensing; and,
- this unit must be assessed in the context of this sector's work environment; and,
- this unit must be assessed using Resources and Infrastructure Industry sector specific policies, procedures, processes and operational manuals; and,
- an assessor must demonstrate the skills and knowledge of this unit through five (5) years' work experience in the Industry sector; and,
- where the assessor does not have current experience a co-assessment or partnership
 arrangement needs to exist between the qualified assessor and an Industry technical
 expert/subject matter expert. The Industry technical expert/subject matter expert must
 hold the unit being assessed and be currently working in the sector with a minimum of
 two (2) years' of current work experience.
