# **Performance Evidence**

Evidence is required to be collected that demonstrates a candidate's competency in this unit. Evidence must be relevant to the roles within this sector's work operations and satisfy all of the requirements of the performance criteria of this unit and include evidence that the candidate:

- · locates and applies relevant documentation, policies and procedures
- implements the requirements, procedures and techniques for the safe, effective and efficient completion of operating and maintaining instruments and field equipment including:
  - · selecting and using relevant tools and equipment
  - using calibration equipment
  - using test equipment
  - applying fault finding procedures
- demonstrates completion of operating and maintaining instruments and field equipment that safely, effectively and efficiently meets all of the required outcomes on more than one (1) occasion including:
  - performing start-up and safety checks
  - · calibrating instruments and field equipment
  - operating instruments and field equipment to perform required measurements
  - performing preventative maintenance and minor repairs
  - identifying instrument and equipment faults
  - · commissioning new instruments and equipment
  - updating maintenance and calibration records, and operational log books

# **Knowledge Evidence**

The candidate must demonstrate knowledge of operating and maintaining instruments and field equipment through:

- applying instrument and equipment test methods
- using and making available manufacturer's operating requirements for instruments and equipment
- applying manufacturer's calibration procedures

#### **Assessment Conditions**

- An assessor of this unit must satisfy the requirements of the NVR/AQTF or their successors; and Industry regulations for certification and licensing; and,
- · this unit must be assessed in the context of this sector's work environment; and,
- this unit must be assessed in compliance with relevant legislation/regulation and using policies, procedures, processes and operational manuals directly related to the industry sector for which it is being assessed; and,
- assessment may be conducted in conjunction with the assessment of other Units of Competency; and,
- assessment must confirm consistent performance can be applied in a range of relevant workplace circumstances; and,
- assessors must demonstrate the performance evidence, and knowledge evidence as outlined in this Unit of Competency, and through the minimum years of current\* work experience specified below in an Industry sector relevant to the outcomes of the unit; or,
- where the assessor does not meet experience requirements a co-assessment or partnership arrangement must exist between the qualified assessor and an Industry subject matter expert. The Industry subject matter expert should hold the unit being assessed (or an equivalent unit) and/or demonstrate equivalence of skills and knowledge at the unit level. An Industry technical expert must also demonstrate skills and knowledge from the minimum years of current work experience specified below in the Industry sector, including time spent in roles related to the unit being assessed; and,
- assessor and Industry subject matter expert requirements differ depending on the Australian Qualifications Framework Level (AQF) of the qualification being assessed and/or Industry Sector as follows:

Industry sector	AQF** Level	Required assessor or Industry subject matter expert experience
Drilling, Metalliferous Mining, Coal	1	1 Year
Mining, Extractive (Quarrying) and Civil Construction	2	2 Years
Drilling, Coal Mining and Extractive (Quarrying)	3-6	3 Years
Metalliferous Mining and Civil	3-6	5 Years
