	2.4 Identify training needs of team members and prepare training plans
	2.5 Prepare and present the pit operations budget
3. Initiate, monitor and adjust the implementation of the	3.1 Issue, explain and clarify the pit plan to team members and others involved, for the safe, effective and efficient implementation of the pit development
pit plan	3.2 Acquire resources for implementation of the pit plan
	3.3 Provide timely ongoing support and advice to those implementing the pit plan
	3.4 Ensure written records and reports are maintained and issued
	3.5 Monitor the pit implementation of the pit plan against pit development parameters, strategies, the budget
	3.6 Resolve variances in consultation with relevant stakeholders and issue instructions for adjustments to the plan
