Dig and load trucks</p> | <p>3.1 Position and set up shovel for safe, efficient digging</p> <p>3.2 Determine and maintain depth of bench, ensure optimum use of bucket capacity</p> <p>3.3 Set and monitor bucket penetration, and ensure optimum bucket load and to minimise overload or strain on shovel</p> <p>3.4 Walk shovel and re-position for safe and efficient operation</p> <p>3.5 Communicate with and direct truck positioning, and ensure safe loading operation</p> <p>3.6 Load material on truck, and ensure bucket clears side of truck and is not swung over truck cabin</p> <p>3.7 Ensure material is placed in the centre of truck tray and does not exceed truck load limit</p> |
