Load, haul and distribute water to complete work activity	<p>3.1 Position water vehicle at loading and/or distribution points</p> <p>3.2 Load water vehicle to within the authorised carrying capacity and to suit the site and task conditions</p> <p>3.3 Operate water vehicle according to site conditions to avoid surge and sway</p> <p>3.4 Discharge or distribute water efficiently in accordance with work requirements and workplace procedures</p> <p>3.5 Monitor discharge of water throughout the operations</p> <p>3.6 Park up, shut down, secure and carry out post operational inspection of equipment in line with workplace procedures</p>
