Performance Evidence

Evidence is required to be collected that demonstrates a candidate's competency in this unit. Evidence must be relevant to the roles within this sector's work operations and satisfy all of the requirements of the performance criteria of this unit and include evidence that the candidate:

- locates and applies relevant documentation, policies and procedures
- implements requirements, procedures and techniques for the safe, effective and efficient completion of support of the drilling process including:
 - operating pressure cleaners
 - applying basic operator servicing and maintenance of plant and vehicles
 - applying communication procedures
 - using lifting equipment
 - identifying weathered and fresh rock
- works effectively with others to undertake and complete the support of the drilling process that meets all of the required outcomes including:
 - complying with written and verbal reporting requirements and procedures
 - communicating clearly and concisely with others to receive and clarify work instructions
 - communicating clearly and concisely with others to resolve coordination requirements prior to commencing and during work activities
- demonstrates completion of the support drilling process that safely, effectively and efficiently meets all of the required outcomes on more than one (1) occasion including:
 - setting up and dismantling ancillary equipment

- carrying out services connections to and from equipment
- · operating and monitoring ancillary equipment
- maintaining stock levels

Knowledge Evidence

The candidate must demonstrate knowledge of the following when supporting drilling processes:

- applying the organisation and site requirements and procedures for:
 - · work health and safety
 - · operational maintenance
 - environmental issues
 - equipment operation
- identifying equipment characteristics, technical capabilities and limitations
- identifying the layout of basic hydraulic circuits
- applying knowledge of hydraulic and pneumatic systems
- interpreting basic geological and technical data
- identifying team roles and objectives
- accessing, reading and interpreting graphical representation, e.g. maps and diagrams
- complying with the requirements to ensure cost effective operations, including work practices that limit damage to equipment and minimise use of consumables

Assessment Conditions

- An assessor of this unit must satisfy the requirements of the NVR/AQTF or their successors; and Industry regulations for certification and licensing; and,
- this unit must be assessed in the context of this sector's work environment; and,
- this unit must be assessed in compliance with relevant legislation/regulation and using
 policies, procedures, processes and operational manuals directly related to the industry
 sector for which it is being assessed; and,
- assessment may be conducted in conjunction with the assessment of other Units of Competency; and,
- assessment must confirm consistent performance can be applied in a range of relevant workplace circumstances; and,
- assessors must demonstrate the performance evidence, and knowledge evidence as
 outlined in this Unit of Competency, and through the minimum years of current* work
 experience specified below in an Industry sector relevant to the outcomes of the unit; or,
- where the assessor does not meet experience requirements a co-assessment or partnership arrangement must exist between the qualified assessor and an Industry subject matter expert. The Industry subject matter expert should hold the unit being assessed (or an equivalent unit) and/or demonstrate equivalence of skills and knowledge at the unit level. An Industry technical expert must also demonstrate skills and knowledge from the minimum years of current work experience specified below in the Industry sector, including time spent in roles related to the unit being assessed; and,

 assessor and Industry subject matter expert requirements differ depending on the Australian Qualifications Framework Level (AQF) of the qualification being assessed and/or Industry Sector as follows:

Industry sector	AQF** Level	Required assessor or Industry subject matter expert experience
Drilling, Metalliferous Mining, Coal Mining, Extractive (Quarrying) and Civil	1	1 Year
Construction	2	2 Years
Drilling, Coal Mining and Extractive (Quarrying)	3-6	3 Years
Metalliferous Mining and Civil Construction	3-6	5 Years
Other sectors	Where this Unit is being assessed outside of the Resources and Infrastructure Sectors assessor and/or Industry subject matter expert experience should be in-line with industry standards for the sector in which it is being assessed and where no Industry standard is specified should comply with any relevant regulation.	

^{*}Assessors can demonstrate current work experience through employment within Industry in a role relevant to the outcomes of the Unit; or, for external assessors this can be demonstrated through exposure to Industry by conducting frequent site assessments across various locations.
