Application

This unit describes the skills and knowledge required to supervise operations in drilling. It prepares individuals to initiate drilling operations, and to monitor, adjust, communicate and report on the execution of drilling operations.

It applies to those working in supervisory or technical specialist roles. They generally perform tasks involving a broad range of varied activities most of which are complex and non-routine.
