4 Monitor and update the quality management processes	4.1 Monitor the reviews statistics and outcomes of the systems procedures, in consultation with others, if procedures and practices need to be modified to meet quality management plan targets
	4.2 Amend the quality management plan and its implementation when changes are anticipated
	4.3 Retain documentation stating reasons for changes
