Application

This unit describes the skills and knowledge required to conduct cage operations in coal and metalliferous mining, including transporting explosives and monitoring and managing cage performance.

It applies to those working in operational roles. They generally work under minimal supervision to undertake a broad range of tasks in varied work contexts, using some discretion and judgement in selecting equipment, services or contingency measures.

Licensing, legislative and certification requirements that apply to this unit can vary between states, territories and industry sectors. Users must check requirements with relevant body before applying the unit.

	3.4 Track and record movement of explosives and detonators according to site requirements
4. Carry out operator maintenance	4.1 Isolate cage according to manufacturer specifications and site requirements
	4.2 Service and make minor adjustments to equipment according to manufacturer specifications and site requirements
	4.3 Restore cage operations according to manufacturer specifications and site requirements
