### Unit Descriptor

This unit covers the installation and maintenance of roadside fixtures in the civil construction industry. It includes planning and preparing, installing guide posts and delineators, erecting guardrails, erecting road fencing, repairing roadside fixtures, maintaining signs, and cleaning up. Licensing, legislative, regulatory and certification requirements that apply to this unit can vary between states, territories, and industry sectors. Relevant information must be sourced prior to application of the unit.

This unit is appropriate for those working in an operational role at worksites within:

Identify, obtain and implement <b>signage</b> requirements from the project traffic management plan 1.5. Select <b>tools and equipment</b> to carry out tasks consistent with the requirements of the job, check for serviceability and rectify or report any faults 1.6. Identify <b>environmental protection requirements</b> from the project environmental management plan, and confirm and apply to the allotted task
2. Install guide posts and delineators	2.1. Set out job to alignment and locations according to job drawings and specifications 2.2. Excavate holes for poles to specification requirements 2.3. Install <b>guideposts</b> to specification 2.4. Install delineators to specification
3. Erect guardrails	3.1. Set out position of <b>guardrails</b> according to drawings 3.2. Finish guardrails according to specifications 3.3. Erect and/or install guardrails in the correct location
4. Erect road fencing	4.1. Set out and excavate positions of <b>fence</b> line and post hole 4.2. Install fence posts plumb and to alignment 4.3. Fit and fix rails, cladding mesh or panels
5. Repair roadside fixtures	5.1. Identify <b>roadside fixture</b> faults and determine methods of repair 5.2. Carry out repairs and routine maintenance

6. Maintain signs	6.1. Maintain <i>signs</i> and support structures 6.2. Carry out repairs 6.3. Replace reflective patches in accordance with cyclic maintenance program
7. Clean up	7.1. Clear work area and recycle or dispose of <i>materials</i> in accordance with project environmental management plan 7.2. Store or stack unused materials 7.3. Clean, check, maintain and store plant, tools and equipment

## Required Skills and Knowledge

This section describes the skills and knowledge required for this unit.

### Required skills

- apply legislative, organisation and site requirements and procedures for installing and maintaining roadside fixtures
- organise work activities
- select and use relevant tools and equipment safely
- identify and report on hazards related to the worksite and work activity
- communicate effectively to receive and clarify work instructions

### Required knowledge

Specific knowledge is required to achieve the Performance Criteria of this unit, particularly for its application in the various circumstances in which this unit may be used. This includes knowledge of the following, as required to install and maintain roadside fixtures:

- roadside signage systems
- civil construction terminology
- types, characteristics and installation/ maintenance techniques of roadside and kerb fixtures
- types, characteristics and installation/ maintenance techniques of roadside fencing
- types, characteristics and installation/ maintenance techniques of roadside fixtures
- site and equipment safety requirements
- site isolation and traffic control responsibilities and authorities
- project quality requirements
- JSAs/safe work method statement

<p><b>Critical aspects for assessment and evidence required to demonstrate competency in this unit</b></p>	<p>The evidence required to demonstrate competency in this unit must be relevant to worksite operations and satisfy all of the requirements of the performance criteria, required skills and knowledge and the range statement of this unit and include evidence of the following:</p> <ul style="list-style-type: none"> <li>• knowledge of the requirements, procedures and instructions for installing and maintaining roadside fixtures</li> <li>• implementation of requirements, procedures and techniques for the safe, effective and efficient completion of roadside fixture installation and maintenance</li> <li>• working with others to undertake and complete the installation and maintenance of roadside fixtures in a way that meets all of the required outcomes</li> <li>• consistent timely completion of the installation and maintenance of roadside fixtures that safely, effectively and efficiently meets the required outcomes</li> <li>• as an individual or as a member of a two-three person team, undertake and complete the following:             <ul style="list-style-type: none"> <li>• installation of 10 metres of guardrail and finish ends</li> <li>• installation of two guide posts and delineators</li> <li>• replacement of two signs, and</li> <li>• erection of 10 metres of roadside fencing to specification</li> </ul> </li> </ul>
<p><b>Context of and specific resources for assessment</b></p>	<ul style="list-style-type: none"> <li>• This unit must be assessed in the context of the work environment. Where personal safety or environmental damage are limiting factors, assessment may occur in a simulated environment provided it is realistic and sufficiently rigorous to cover all aspects of workplace performance, including task skills,</li> </ul>

	<p>task management skills, contingency management skills and job role environment skills.</p> <ul style="list-style-type: none"> <li>• Assessment of this competency requires typical resources normally used in a resources and infrastructure sector environment. Selection and use of resources for particular worksites may differ due to the site circumstances.</li> <li>• The assessment environment should not disadvantage the participant. For example, language, literacy and numeracy demands of assessment should not be greater than those required on the job.</li> <li>• Customisation of assessment and delivery environment to sensitively accommodate cultural diversity.</li> <li>• Aboriginal people and other people from a non English speaking background may have second language issues.</li> <li>• Where applicable, physical resources should include equipment modified for people with disabilities. Access must be provided to appropriate learning and/or assessment support when required.</li> </ul>

<p><b>Safety requirements</b> may include:</p>	<ul style="list-style-type: none"> <li>• OHS requirements in accordance with state or territory legislation and regulations, organisational safety policies and procedures, and project safety plan, including protective clothing and equipment, use of tools and equipment, workplace environment and safety, handling of materials, use of fire fighting equipment, use of First Aid equipment, hazard control and hazardous materials and substances</li> <li>• safe operating procedures including recognising and preventing hazards associated with high voltage power lines, uneven/unstable terrain, trees, overhead service lines, bridges, surrounding buildings, obstructions, structures, facilities, dangerous materials, recently filled trenches, other machines, personnel, traffic control, working at heights, working in proximity to others, worksite visitors and the public</li> <li>• safe parking practices including ensuring access ways are clear, equipment/machinery is away from overhangs and refuelling sites, safe distances are kept from excavations, and areas secured from unauthorised access or movement</li> <li>• recognising hazards and risks including uneven/unstable terrain, trees, fires, overhead and underground services, bridges, buildings, excavations, traffic, embankments, cuttings, structures and hazardous materials</li> <li>• emergency procedures related to equipment</li> </ul>

	operation including emergency shutdown and stopping, extinguishing equipment fires, organisational First Aid requirements and evacuation
<b>Signage</b> may include:	<ul style="list-style-type: none"> <li>• escort vehicles</li> <li>• highway traffic signs</li> <li>• site safety signage</li> <li>• temporary signage for the benefit of motorists and pedestrians</li> <li>• barricades</li> <li>• traffic conditions signage</li> </ul>

<b>Guideposts</b> may include:	<ul style="list-style-type: none"> <li>• timber</li> <li>• plastic</li> <li>• steel/galvanised</li> <li>• associated installation devices</li> </ul>
<b>Guardrails</b> may be either:	<ul style="list-style-type: none"> <li>• rigid</li> <li>• flexible</li> </ul>
<b>Fence</b> may include:	<ul style="list-style-type: none"> <li>• chainwire</li> <li>• mesh</li> <li>• plain wire</li> <li>• barbwire</li> <li>• netting</li> </ul>

<b>Roadside fixtures</b> may include:	<ul style="list-style-type: none"> <li>• guard rails</li> <li>• guide posts</li> <li>• fencing</li> <li>• signs</li> </ul>
<b>Signs</b> may include:	<ul style="list-style-type: none"> <li>• traffic hazard signs</li> <li>• street signs and lights</li> <li>• speed signs</li> <li>• destination</li> <li>• information signs</li> <li>• tourist signs</li> <li>• supportive framework</li> <li>• poles</li> <li>• posts</li> </ul>
<b>Materials</b> may include:	<ul style="list-style-type: none"> <li>• aluminium sections</li> <li>• steel sections</li> <li>• timber</li> <li>• concrete</li> <li>• brackets and fastenings</li> <li>• bolts</li> <li>• bearers and uprights</li> <li>• paints</li> <li>• fencing materials</li> <li>• reflective materials</li> <li>• footing materials</li> </ul>
