It involves a prescribed range of tasks involving known routines and procedures and taking some accountability for the quality of work outcomes.

#### Job roles

Job roles and titles vary across different sectors. Possible job titles relevant to this qualification include:

- commercial driver
- courier driver
- light rigid driver
- pickup and delivery driver
- ride share driver
- taxi driver
- tow truck driver.

Successful achievement of the licensing units within the qualification must align with licensing and regulatory requirements applicable to driving and state or territory regulatory requirements.

## **Entry Requirements**

There are no entry requirements for this qualification.

A total of **16 units of competency** comprising:

- 5 core units listed below, plus
- 1 licensing/industry elective unit from the licensing/industry elective units listed below, plus
