Release 1. This is the first release of this unit of competency in the TLI Transport and Logistics Training Package.

Performance Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria on at least one occasion and include:

- applying precautions and required action to minimise, control or eliminate identified hazards
- · applying workplace procedures
- communicating effectively with others
- completing relevant documentation
- conducting checks on transfer equipment
- estimating size, shape and special requirements of cargo
- following relevant instructions, procedures, information and signs
- identifying, selecting and using relevant equipment, processes and procedures
- monitoring performance of transfer equipment
- operating and adapting to differences in equipment in accordance with workplace procedures
- reporting hazards and faults in accordance with workplace procedures
- using personal protective equipment (PPE) in accordance with workplace procedures.

Knowledge Evidence

Evidence required to demonstrate competence in this unit must be relevant to and satisfy all of the requirements of the elements and performance criteria and include knowledge of:

- Australian and international standards, codes and regulations relevant to transferring cargo/freight, including the current Australian Dangerous Goods (ADG) Code
- cargo marking and numbering systems
- licensing requirements for transfer equipment
- relevant work health and safety (WHS)/occupational health and safety (OHS) workplace procedures
- reporting of identified hazards, faults or malfunctions in accordance with workplace procedures
- types of equipment used to transfer cargo, their applications, procedures and precautions for their use
- working load limit (WLL) of cargo transfer equipment
- workplace procedures and policies for handling and transferring cargo
- workplace procedures for using transfer equipment.

Assessment Conditions

Assessors must hold credentials specified within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must satisfy the Principles of Assessment and Rules of Evidence and all regulatory requirements included within the Standards for Registered Training Organisations current at the time of assessment.

Assessment must occur in workplace operational situations where it is appropriate to do so; where this is not appropriate, assessment must occur in simulated workplace operational situations that replicate workplace conditions.

Assessment processes and techniques must be appropriate to the language, literacy and numeracy requirements of the work being performed and the needs of the candidate.

Resources for assessment must include:

- relevant materials, tools, transfer equipment and personal protective equipment (PPE)
- applicable documentation, including workplace procedures, regulations, codes of practice and operation manuals.
