Release 1. This is the first release of this unit of competency in the TLI Transport and Logistics Training Package.

Application

This unit involves the skills and knowledge required to analyse and apply knowledge of materiel logistics in accordance with relevant organisational policy and procedures.

The application of this knowledge is required by people who are not materiel logistics specialists but who need the knowledge to inform their decision making. The application of materiel logistics knowledge is specific to a variety of component processes in integrated logistics support and materiel sustainment activities.

This unit was developed for logistics specialists working within materiel logistics but may be applicable to individuals in broader logistics roles or those in non-logistics roles who are in decision making roles relevant to logistics.

Individuals work independently or as part of a team under direct or indirect supervision, use discretion and judgement, and take responsibility for the quality of their outputs.
